北部都會區的建造繼續如火如荼的推展中，不少客戶除了關注大規模的收地搬遷行動，亦思量如何迎接片區開發帶來的機遇及挑戰。持有市區物業的不少客戶亦關注新區發展對樓價帶來的影響。考慮到舊區舊樓正面對更嚴格的保養及維修規管，而北部都會區的新區要時間成熟，短期將引致舊區新舊樓價差拉闊，市區的收購重建活動將隨著更多政策支持，例如容積率轉移，而逐步提升。

The development of the Northern Metropolis is progressing vigorously. Many clients, in addition to paying attention to large-scale land resumption and site relocation, are also considering how to embrace the opportunities and challenges brought by the area's development. Numerous clients holding urban properties are also concerned about the impact of new district developments on property prices. Given that aging buildings in decay urban area are facing stricter maintenance and repair regulations, and that the new areas in the Northern Metropolis will take time to mature, there will be a widening price gap between old and new buildings in urban area in the short term. Meanwhile, it is anticipated that the activities of acquisition and redevelopment in the urban area will gradually increase with more policy support, such as the policy of transfer of plot ratios.

企業評值及諮詢 Corporate Valuation and & Advisory



恒生指數 (HSI) 於2025年全年上升27.8%，收報約25,600至26,000點，繼2024年上升17.7%後，連續兩年錄得強勁復甦。這輪升勢主要受惠於南向資金持續流入、科技板塊對人工智能的樂觀情緒、全球降息周期，以及大中華區經濟前景信心改善所帶動。香港市場總市值創歷史新高，平均每日成交額突破1,500億港元，反映各行各業的流動性均有所加深。

截至2025年底，恒指市盈率穩定於約13至14倍，雖低於疫情期間超過18倍的高位，但亦較2024年低位的11至12倍顯著回升，顯示估值已回歸合理水平且具吸引力。各行業表現分化，其中恒生科技指數上升23.5%，原材料板塊更勁升161%，反映市場動能分佈不均。

整體估值倍數的擴張顯示投資者信心增強。利率下調推高貼現現金流估值，而可比公司倍數的回升，尤其是科技股市盈率接近25倍，進一步鞏固了香港股市的合理價值基準。熱門板塊如人工智能、生物科技（恒生生物科技指數 +64.5%）、半導體及原材料行業，皆錄得較高的市盈率，帶動整體估值曲線上移；相對而言，公用事業（+5.7%，約10至12倍市盈率）及必需消費品（+9.6%，約17倍市盈率）等傳統行業雖升幅溫和，但其估值亦有擴張。永利行為新興及傳統行業提供企業估值及收購價格分配（PPA）服務，協助企業處理不同的併購驅動因素，包括高科技行業的增長型收購，以及傳統行業的重組交易。

The Hang Seng Index (HSI) advanced 27.8% in 2025, closing around 25,600 to 26,000 points after a 17.7% rise in 2024, marking two consecutive years of robust recovery. The rally was supported by sustained mainland capital inflows from Southbound funds, optimism surrounding artificial intelligence in the technology sector, global interest rate cuts, and improving confidence in the economic outlook for Greater China. Market capitalization in Hong Kong reached a record high, while average daily turnover exceeded HK\$150 billion, reflecting deeper liquidity across industries.

By the end of 2025, the HSI's P/E ratio stabilized at 13-14x. This was below the pandemic era peak above 18x but higher than the 2024 trough of 11-12x, suggesting a return to normalized yet attractive valuations. Sector performance varied significantly, with the Hang Seng TECH Index gaining 23.5% and raw materials companies surging 161%, revealing uneven momentum across the market.

The broader expansion in valuation multiples illustrates growing investor optimism. Lower interest rates enhanced discounted cash flow valuations, while rising comparable multiples—particularly among technology companies trading near 25x P/E—reinforced fair value benchmarks in Hong Kong's equity market. Whilst trending industries such as AI, biotech (Hang Seng Biotech Index +64.5%), semiconductors, and materials reflected elevated P/Es and pulled the overall curve upward, traditional industries like utilities (+5.7%, ~10-12x P/E) and consumer staples (+9.6%, ~17x P/E) lagged with more subdued growth yet still experienced expanding P/Es. RHL provides business valuations and purchase price allocation services for both trending and traditional industries, addressing their distinct M&A drivers such as growth acquisitions in high-tech sectors and restructuring deals in traditional sectors.

企業出海2.0如火如荼，2025年中國企業對外投資達到約1600億美元，同比增長7.1%，重點聚焦於物流、汽車、半導體、高端製造、房地產等核心賽道。其中中國房地產企業憑藉其在基建開發、產業聯動及品牌運營上的深厚沉澱，正積極向海外輸出“中國經驗”，佈局酒店、物流地產及產業園區等高潛力領域。我們有幸參與其中，在今年協助客戶為一幅位於哈薩克斯坦重要交通樞紐的土地進行估值，客戶計劃建成包括倉庫，寫字樓，商業及配套的綜合物流項目，這也是我們在中亞市場的又一個經驗累積。作為中國國資委認可的境外評估師，我們將繼續發揮多年來在海外市場累積的評估、盡調與可行性分析經驗，以專業服務為中國客戶出海護航。

China's overseas expansion 2.0 is in full swing, with outbound investment reaching approximately \$160 billion in 2025, a 7.1% year-over-year increase, primarily focused on core sectors including logistics, automotive, semiconductors, high-end manufacturing, and real estate. Leveraging their deep expertise in infrastructure development, industrial and real estate synergy, and brand operations, Chinese developer are actively exporting “Chinese experience” overseas, expanding into high-potential sectors like hotels, logistics, and industrial parks. We are privileged to be part of it, we have provide valuation service for a client in investing a land parcel located at a key transportation hub in Kazakhstan this year. The client plans to develop a comprehensive logistics project featuring warehouses, office buildings, commercial spaces, and supporting facilities. This marks another valuable experience for us in the Central Asian market. As an off-shore valuer recognized by China's State-owned Assets Supervision and Administration Commission (SASAC), we will continue to leverage our years of expertise in valuation, due diligence, and feasibility analysis in overseas markets to provide professional services that safeguard Chinese clients' international ventures.
